SEPARATION

① OPTIONAL RETIREMENT - In accordance with existing regulations Mr. Friedman is eligible for Optional Retirement. The following information was obtained from the Retirement Division, Civil Service Commission (Mrs. Wedsell) on 25 May 1955. The figures quoted are reasonably accurate but are not exact.

Mr. Friedman's Retirement Annuity entitlements were computed on the basis of 33 years .5 months service at an average 5 highest yr. Annual income of \$12,209 per annum.

Based on this service, under the Life Annuity Plan (which provides for no survival benefits), Mr. Friedman would receive a monthly annuity of \$450.⁰⁰, computed as follows.
