IN THE AFTERMATH OF THE CAPTURE OF THE USS PUEBLO BY NORTH KOREAN PATROL CRAFT AND ITS SUBSEQUENT ESCORT INTO WONSAN HARBOR, AND CONTINUING UNTIL THE STATUS OF THE VESSEL AND THE NATURE OF US ACTION IS RESOLVED, IT IS ESPECIALLY IMPORTANT THAT ALL ASSIGNED TARGET COMMUNICATIONS BE CAREFULLY SCRUTINIZED FOR ANY REFLECTIONS OF OR ACTIVITY RELATED TO THIS EVENT.
2. REPORTING OF ANY OBVIOUS OR SUSPECTED REFLECTIONS SHOULD BE IN ACCORD WITH EXISTING CRITIC, SPOT, ELECTRIGRAM AND TRANSLATION CRITERIA.
3. USE OF SIR VEHICLE IS ENCOURAGED FOR ALL ACTIVITY THAT IS QUESTIONABLE AND NOT EASILY RESOLVED BY YOU FOR PRODUCT RELEASE. ON SIR DISTRIBUTION: EXPAND [redacted] ADDRESS BLOCK TO READ QUOTE [redacted] (ATTN: WATCH OFFICE) UNQUOTE.
