NORTH VIETNAM ON 5 JUNE, BT 18 INFORMED THE K185 WAREHOUSE AT THAI HOA THAT IT WAS GOING TO CONSTRUCT A WAREHOUSE AT TAN KY (UNLOCATED) TO \$CREATE A CARGO BASE TO THE FRONT. \$ K185 WAS FURTHER ORDERED TO SEND TWO PERSONNEL TO INSPECT THE AREA TO DETERMINE A SITE FOR THE WAREHOUSE. AN EARLIER REPORT OF THE SAME DAY MENTIONED THAT CIVILIAN LABORERS WOULD BE BROUGHT IN TO IMMEDIATELY STOCK THE AREA WITH FROM 3,000 TO 5,000 TONS OF UNSPECIFIED TYPE CARGO.
