 DIFFERENCES OF TRACKING AS BROADCAST BY THE NA SAN FILTER CENTER AND THE
 NATIONAL AIR SURVEILLANCE HEADQUARTERS AT HANOI; HOWEVER, IT IS ASSUMED THAT
 HANOI MAY HAVE BEEN RECEIVING ADDITIONAL RADAR INPUT FROM STATIONS IN THE HANOI
 AREA, THE LAST NOTED POSITION OF THIS RAID AT 1720 WOULD PUT THE UNIDENTIFIED
 \$HOSTILES\$ WITHIN THE 220 TO 300 DEGREE AZIMUTH FROM 20-58N 105-58E WHICH WAS
 STATED TO BE THE AREA OF RESCUE OPERATIONS FRO THE \$PIRATE\$ AIRMAN\$ ON 17
 OCTOBER. COMMENT, COLLATERAL INFORMATION INDICATES THAT A U.S. F-111 WAS LOST
 DURING THE 1700 HOUR ON 16 OCTOBER. NO APPARENT CAUSE FOR THE MISSING AIRCRAFT
 HAS BEEN NOTED, NOR HAVE THERE BEEN ANY ADDITIONAL REFLECTIONS OF ANY ALLIED
 SEARCH OPERATIONS IN THE NEAR 20-08N 104-17E. 420 #0663 NNNN
