 SHOULD WE TAKE THE SAPPER UNIT FROM THE FRONT OR FROM THE  
 COOPERATIVE AT ((FEW WORDS UNKNOWN))" ((YOUR REQUEST)) WAS  
 NOT CLEAR. WE HAVE ALREADY SELECTED ((A UNIT)) FROM THE  
 COOPERATIVE. ((A)) PROBABLY SECRETARY OF KC SECTOR 13.
