Requests for release dated 24 April 1962, and allegedly signed by FRANCIS QUINN((B)) and GEORGE EDWARD GROOM((B)) were sent to the National Front for the Liberation of South Vietnam and the "Liberation Army Command" [BO CHI HUYNH GIAI PHONG QUAN]", according to LNA. The text of QUINN's request, published in toto by LNA, attests to the excellent treatment QUINN received,

and declares that "I was deceived by the American authorities into believing that I was coming to South Vietnam to assist in building up Mr. DIEM's army, whereas in reality it was to take direct command of this army so as to suppress the righteous struggle of the people of South Vietnam." The letter further states: "I sincerely promise that when I return to the United States, I will tell the people of my country and my fellow soldiers about the righteous struggle of the South Vietnamese people and the war-mongering aggressive plots of the Americans here."

Excerpts of the letter allegedly signed by GROOM were similar in content.
