ANALYSIS OF DRV SAM-RELATED COMMUNICATION18 AUGUST INDICATES THAT ONE, POSSIBLY TWO HOSTILE AIRCRAFT WERE DESTROYED IN THE VICINITY OF LUC NAM (21-18N E). ONE OF THE HOSTILE PLANES WAS IDENTIFIED AS A F-105 AND THE PILOT WAS REPORTED AS CAPTURED. POST LAUNMUNICATIONS REFLECTED TWO SEPARATE DISCUSSIONS RELATED TO THE SHOOTDOWN OF THE HOSTILE AIRCRAFT. THE FIRST CONVE SATION WAS NOTED BETWEEN 0816 AND 0849 AND THE SECOND BETWEEN 0910AND 0922. THE INITIAL DISCUSSIONS REVEALED THATRACKS OF HOSTILE AIRCRAFT, EACH UNAMPLIFIED AS TO NUMBER OR TYPE, WERE TRACKED BY SAM FACILITIES. DIRING THT FOUR MINUTES OF INTERCEPT ONE OF THE TRACKS REPORTEDLY HAD PROCEEDED SOUTH FROM A POINT 30 NAUTICAL MILES NOT OF HANOI TO A LAST NOTED POSITION 19 NAUTICAL MILES EASTOF HANOI. NO POSITIONS WERE REVEALED FOR THE OTHER TRAC DURING THE TIME THAT THIS ACTIVITY WAS TAKING PLACE IT WAS ALSOREVEALED THAT TWO MISSILES HAD BEEN FIRED AT 081ADDITION, IT WAS REVEALED THAT TWO AIRCRAFT WERE TOTALLY DESTROYED IN THE GENERAL VICINITY OF LAC NAM. THATAAA AY POSSIBLY HAVE DESTROYED A SECOND TRAGET AND THAT A PILOT WAS CAPTURED. COMMENTS: THE SAM SITE LOCATED ATN 105-50E AND AN UNLOCATED SAM SITE WERE EXCHANGING TRACKING INFORMATION OF WHICH AT LEAST MSOME WAS PROBABLY RATION ON THE TARGETS.
