SECTION THREE - DRV MULTICHANNEL COMMUNICATIONS REFLECT THE DESTRUCTION OF AN F4 AIRCRAFT. FRAGMENTARY DRV MULTICHANNEL COMMUNICATION INTERCEPT OBTAINEDON 9 AND 1\$ OCTOBER, REFLECT THE DESTRUCTION OF ONE F4 AIRCRAFT AND THE CAPTURE OF THE THO PILOTS.
