 DETERMINED, ALTHOUGH IT IS PROBABLY IN CHINA. DURING THE LAST APPEARANCE OF
 THE KUANGCHOU SERVICE UNIT, IT WAS ENGAGED IN AN EXCHANGE OF MESSAGES WITH A
 CONSTRUCTION- RELATED UNIT WHICH WAS TO REPLACE THE SERVICE UNIT, THEN LOCATED

ON ONE DECEMBER, COMMUNICATIONS SERVING THE SENIOR CHICOM AUTHORITY IN HANOI STRENGTHENED THE POSSIBILITY THAT THE CCAF 101ST AAA DIVISION IS LOCATED IN NORTH VIETNAM. EVIDENCE THOUGH LIMITED, SUGGESTS THE 101ST AAA DIVISION IS SERVED BY THE RADIO STATION THAT PROVIDES COMMUNICATIONS FOR THE CCAF 103RD AAA DIVISION LOCATED IN THE LANG SON AREA OF NORTH VIETNAM. THE 103RD AAA DIVISION HAS DIRECT CONTACT WITH THE SENIOR CHICOM AUTHORITY, THE KUANGCHOU MILITARY REGION HEADQUARTERS, AND THE NANNING REGIONAL REAR SERVICES AUTHORITY. WHETHER THIS IS A REPLACEMENT OR AN AUGMENTATION OF THE 103RD AAA DIVISION BY THE 101ST AAA DIVISION CANNOT BE DETERMINED AT PRESENT (SEE 24 [REDACTED] C642-66, 020331Z, SPOT REPORT).
