SAM ASSOCIATED COMMUNICATIONS REFLECT TWO SHOTDOWNS AND TWO U.S. PILOT

CAPTURES.

DRV SAM ASSOCIATED COMMUNICATIONS ON 26 FEBRUARY HAVE REFLECTED A PROPAGANDA MESSAGE REVEALING A CLAIM OF TWO SHOTDOWNS AND THE CAPTURE OF TWO U.S. PILOTS. BETWEEN 0251 AND 0310, AN UNIDENTIFIED SPEAKER, PROBABLY A REGIMENTAL CONTROLLER, READ A PROPAGANDA MESSAGE TO AN UNKNOWN RECIPIENT DURING WHICH TWO SHOTDOWNS AND TWO PILOT CAPTURES WERE REPORTED. AT 0251, THE SPEAKER STATED: "ON THE MORNING OF FEBRUARY 23, 1968, OUR AIR FORCE SHOT DOWN IN PLACE ONE F4 (AND) CAPTURED THE PIRATE PILOT, (AND ON THE) NIGHT OF FEBRUARY 24, 1968, A MISSILE SHOT DOWN ON THE SPOT ONE A6 (AND) CAPTURED ALIVE THE PIRATE PILOT". CONTINUING, THE SPEAKER POINTED OUT THAT THEIR FORCES WERE IMPROVING IN SKILL AND URGED ALL UNITS TO PRACTICE AND STRIVE TO IMPROVE THEIR COMBAT TECHNIQUES. FURTHER COMMUNICATIONS REVEALED ONLY A REITERATION OF THE MESSAGE URGING ALL TO "SHOOTDOWN THE ENEMY ON THE SPOT AND CAPTURE ALIVE MANY (OF THE) PIRATE PILOTS". COMMUNICATIONS DID NOT REVEAL THE LOCATION OR CONDITION OF EITHER OF THE TWO PILOTS AND NO FURTHER COMMUNICATIONS WERE NOTED. COMMENTS: THE SHOOTDOWN OF THE F4 ON FEBRUARY 23 AS REVEALED IN THE MESSAGE IS IN PROBABLE REFERENCE TO THE SHOOTDOWN OF A U.S. F-4 STRIKE AIRCRAFT BY A MIG21 PILOT DURING THE A.M. STRIKES ON 23 FEBRUARY [REDACTED] EGRAM 2 [REDACTED] VCA/R103-68 DTG: 232130Z REFERS). THE REFERENCE TO THE SAM SHOOTDOWN ON FEBRUARY 24 PROBABLY RELATES TO A DRV SAX ASSOCIATED REPORTED SHOOTDOWN OF A U.S. A-6 AIRCRAFT IN THE HANOI EAST REGIMENT AREA DURING THE 1200 HOUR ON THIS DATE (DETAILS OF WHICH WILL BE FORTHCOMING IN AN EGRAM, 24 [REDACTED] VCK/R065-68, FROM THIS CENTER).
