NATIONAL SECURITY AGENCY DAILY GENERAL DIRECTORATE OF REAR SERVICES SUMMARY NUMBER 113, 23 APRIL 1970 XXCC THIS REPORT PROVIDES A DAILY RECAPITULATION OF ACTIVITY NOTED IN THE COMMUNICATIONS SERVING THE GENERAL DIRECTORATE OF REAR SERVICES (GDRS) TO INCLUDE INFILTRATION AND OPERATIONAL INFORMATION WITHIN NORTH VIETNAM AND ADJACENT AREAS, AND IS BASED UPON SIGINT (EXCEPT WHERE OTHERWISE INDICATED) MADE AVAILABLE TO NSA DURING THE LAST 24 HOURS. FOR LOCATIONS OF NVA GDRS FACILITIES, SEE 2/0/VCJ/R427-69. I. SITUATION SUMMARY REAR SERVICES COMMUNICATIONS WERE HIGHLIGHTED BY FURTHER REFERENCES TO DIFFICULTIES CAUSED BY RAIN AND MUD IN THE PANHANDLE AND TO THE NORTHWARD MOVEMENT OF TWO AMERICAN PRISONERS AND ONE JAPANESE PRISONER. TO DATE, 7 INFILTRATION GROUPS AND 11 \$QL\$-DESIGNATED GROUPS HAVE BEEN OBSERVED. II. NORTH VIETNAM 1. A 20 APRIL DISPATCH TO BINH TRAM (BT) 18 FROM WORKCAMP (CT) 12 INFORMED THE BINH TRAM THAT T-19 HAD TAKEN TWO AMERICAN PRISONERS AND ONE JAPANESE PRISONER TO T-12 PROBABLY ON 20 APRIL. THE MESSAGE FURTHER INFORMED BT 18 THAT THESE PRISONERS WERE TO BE TAKEN TO T-17 THE FOLLOWING DAY. ON THE NEXT DAY, 21 APRIL, A MESSAGE WAS SENT TO BT 18 INFORMING THEM OF THE TRANSFER OF PERSONNEL FROM T-12 TO T-17 AND REFERENCED THREE \$ADDITIONAL\$ AMERICAN PRISONERS ALSO BEING SENT TO T-17. IT IS NOT BELIEVED THAT THE PRISONERS MENTIONED IN THIS 21 APRIL MESSAGE ARE IN FACT IN ADDITION TO THOSE REPORTED ON THE 20TH. ANOTHER MESSAGE OF 21 APRIL REFERRED TO THE SAME PERSONNEL MOVING NORTH AND AGAIN MENTIONED THREE PRISONERS. THEREFORE, JUDGING FROM THE ABOVE REFERENCES TO PRISONERS AND TRAVEL TIMES IT IS BELIEVED THAT ONLY THREE PRISONERS -- TWO AMERICANS AND ONE JAPANESE -- ARE EN ROUTE TO T-17. (2/0/VCJ/T1694-70, 211705Z) 2. A PERSONNEL REPORT FROM CT 10 TO BT 18, ON 22 APRIL, CONTAINED THE FOLLOWING INFORMATION, REMAINING AT CT 10, 163 PERSONNEL FROM PREVIOUS DAYS. RECEIVED, 42, INCLUDING 28 WOUNDED AND 14 SICK. DISPATCHED, TO CT 12, 152 PERSONNEL INCLUDING POSSIBLY 76 WOUNDED AND 76 SICK. FROM POSSIBLY B3, 1 WOUNDED AND 2 SICK; B-2, 1 SICK AND 1 WOUNDED; B1, TWO SICK. NOW REMAINING, 49 PERSONNEL, INCLUDING 30 WOUNDED AND 19 SICK. REMAINING AT T-12, 65 PERSONNEL. RECEIVED BY T-12, 148 PERSONNEL DISPATCHED BY T-12, 148 PERSONNEL. AMONG THOSE REMAINING WERE 17 WOMEN AND 4 CHILDREN, 7 PEOPLE FROM MR 4, 6 STRAGGLERS AND 36 TRANSFEREES. FROM CT 6 TO CT 8 WAS REFLECTED IN SEVERAL 21 APRIL MESSAGES FROM BT 26. AT 1600(G) ON 21 APRIL, 186 SICK AND WOUNDED PERSONNEL WERE SCHEDULED TO BE MOVED TO CT 8 BY BARGE. THEIR EATING STANDARD WAS AS FOLLOWS, 2.5 DONG - 2 1.6 DONG - 51 1.0 DONG - 133 ON POSSIBLY 22 APRIL, 144 SICK AND WOUNDED PERSONNEL WERE SCHEDULED FOR MOVEMENT. THE FOOD STANDARD, 2.5 DONG - 2 1.6 DONG - 48 1.2 DONG - 94 ANOTHER 150 SICK AND WOUNDED WERE SCHEDULED FOR 23 APRIL. 2. A 21 APRIL MESSAGE FROM THE BT 26 AREA, DISCLOSED THAT 158 SICK AND WOUNDED PERSONNEL WERE REMAINING POSSIBLY AT CT 8. II. LAOS GENERAL DEVELOPMENTS XXHH 900 NNNN
