1. MY TELEGRAM 0153 DEFINES CLEARLY THE FORMULA FOR STGNING.
PLEASE NOTE THAT THERE IS ONLY ONE DOCUMENT. HOWEVER, I EMPHASIZE
THAT WE CAN SIGN ONLY AFTER WE HAVE APPROVED THE TEXT OF THE
AGREEMENT. THE QUESTION OF THE MODALITIES OF SIGNING COMES IN ORDER
OF PRIORITY AND URGENCY AFTER THE TEXT OF THE AGREEMENT. THEREFORE,
IN AS MUCH AS THE TEXT OF THE AGREEMENT HAS NOT RESOLVED OUR ESSENTIAL
POINTS MENTIONED IN PRESIDENT ((THIEU))'S LETTERS OF 20 DECEMBER AND
7 JANUARY, ((WHICH)) ARE NOT RESOLVED TO THE SATISFACTION OF THE
VIETNAMESE GOVERNMENT, THE VIETNAMESE GOVERNMENT IS NOT YET ABLE

IF THE VIETNAMESE GOVERNMENT APPROVES THE TEXT OF THE AGREEMENT IT WILL SIGN IN ACCORDANCE WITH THE FORMULA DESCRIBED IN MY CABLE 0153. HOWEVER, I CALL TO YOUR ATTENTION THAT THE TEXT OF THE AGREEMENT WHICH THE U.S. SIDE CONSIDERS VIRTUALLY FINALIZED STILL LEAVES UNRESOLVED OUR BASIC POINTS WHICH WERE DESCRIBED IN THE PRESIDENT'S LETTER.

2. PLEASE INFORM THE U.S. SIDE THAT HE HAVE RECEIVED ONLY THE ENGLISH VERSION OF THE PROTOCOL TEXTS. OUR TASK FORCE HERE HAS ALREADY BEGUN TO WORK ((ON THEM)). ONLY AFTER WE HAVE COORDINATED MATTERS WITH YOUR TASK FORCE OVER THERE WILL HE BE ABLE TO SAY WHETHER IT IS ACCEPTABLE OR NOT.

3. PLEASE CONVEY THIS INFORMATION TO THE U.S. SIDE, USING AS A BASIS MY CABLE 0153 AS WELL AS THIS ONE.
