SOUTH VIETNAMESE NEGOTIATOR REPORTS CONCLUSION OF SECRET TALKS BETWEEN KISSINGER AND LE DUC THOS PROGRESS ON PROTOCOLS FR PARISS SOUTH VIETNAMESE DELEGATIONS ((AMBASSADOR)) PHAM DANG LAM 13 JAN 73 2200 TO SAIGON: PRESIDENT'S OFFICES COMMISSIONER GENERAL HOANG DUC NHA

PRIOR TO HIS DEPARTURE ((FROM PARIS)) ((KR. HENRY A.)) KISSINGER STATED THAT HE HAS ALREADY CONCLUDED THE SECRET NEGOTIATIONS WITH LE DUC THO AND THAT ((DEPUTY ASSISTANT SECRETARY OF STATE WILLIAMH.)) SULLIVAN WILL REMAIN ((IN PARIS)) A FEW DAYS IN ORDER TO CONCLUDE THE PROTOCOLS.

IN HIS BREEFING OF US AFTER DISSINGER'S DEPARTURE, SULLIVAN CONFIRMED THAT THE DRAFT OF THE ACCORD IS CONSIDERED AS DEFINITELY CONCLUDED. TODAY KISSINGER PRESENTED OUR FORMULA FOR SIGNING BUT LE DUCTHO REJECTED IT, IT, INSISTING ON THE SIGNING OF TWO TEXTS,

DNE ((TEXT)) FOR TWO ((SIGNATURES)) AND THE OTHER ((TEXT)) FOR FOUR
((SIGNATURES)). WE REAFFIRMED OUR POSITION: THE SIGNING OF A SINGLE
DOCUMENT BETWEEN TWO SIDES. WZ ALSO STRESSED THAT WE DO NOT AGREE:
TO THE MENTION OF THE WORDINGS "ON BEHALF OF," "WITH THE
CONCURRENCE OF" OR "IN CONCERT WITH." SULLIVAN CONSIDERS THAT THE
U.S -- DRY ((DEMOCRATIC REPUBLIC OF VIETNAM)) DOCUMENT IS NOT BINDING UPON US, (LAND)) THE WORDING "WITH THE CONCURRENCE OF" ONLY
SIGNIFIES THAT "YOU GIVE US PERMISSION TO DO ((THE)) THINGS WE ARE
DOING." SULLIVAN TOLD US THAT AMBASSADOR ((ELLSWORTH)) BUNKER WILL
PROVIDE ALL OF THE EXPLANATIONS IN SAIGON, REGARDING THE PROTOCOLS,
NEARLY ALL OF TH ISSUES HAVE ALREADY BEEN SETTLED OR IT HAS BEEN
STIPULATED TO LEAVE THEM TO THE TWO SOUTH VIETNAMESE PARTIES TO
DISCUSS AFTER THE SIGNING OF THE ACCORD (CRITERIA FOR DETERMINING

CEASE-FIRE LINES AND THE SETTING UP OF THE TWO PARTY COMMISSION). TODAY AGREEMENT WAS REACHED ON TWO NEW POINTS! NAMELY, THE STRENGTH OF THE ICCS (CINTERNATIONAL COMMISSION OF CONTROL AND SUPERVISION)) WAS SET AT 12160. AND THAT FOR THE FOUR PARTY COMMISSION WHICH IS TO BEISET UP ((WAS SET)) AT 32300. KISSINGER HAS SUGGESTED THAT AMBASSADOR TRANKIN PHUDNG RETURN TO WASHINGTON: IN ORDER TO STAY IN TOUCH WITH HIM DURING THIS CRO-
