((HEYHARD)) ISHAM PROVIDED AN INTERIM U.S. DELEGATION, REPLACING AMBASSADOR ((WILLIAM J.)) PORTER, WHO LEFT PARIS YESTERDAY, 10 DECEMBER. I REPLACED AMBASSADOR PHAM DANG LAM.

TWO ZONES OF CONTROL, AND THREE POLITICAL FORCES IN SOUTH VIETNAM; WHILE NGUYEN MINH VY CALLED FOR A HALT TO THE BOMBINGS IN ALL OF THE TERRITORY OF NORTH VIETNAM AND CESSATION OF THE VIETNAMIZATION PROGRAM AS A PROOF OF GOODWILL ((IN THE SPIRIT OF THE)) OCTOBER ACCORD.

2. AFTER THE BREAK I TOOK THE FLOOR FOR 25 MINUTES. I REAFFIRMED DNCE AGAIN DUR POSITION CONCERNING A REAL, GENERAL, AND EFFECTIVELY CONTROLLED CEASEFIRE; THE WITHDRAWAL OF NORTH VIETNAMESE TROOPS; AND THE ADMISSION OF THE REALITY OF TWO SOVEREIGN AND INDEPENDENT VIETNAMESE STATES ((AS)) CONDITIONS NECESSARY FOR A TRUE AND LASTING PEACE. AFTER THE SPEECH I CATEGORICALLY REJECTED THE COMMUNIST THESIS ON THE REALITY OF SOUTH VIETNAM, EMPHASIZING THAT THERE IS ONLY ONE LEGAL AND ELECTED GOVERNMENT, THE GRYN ((GOVERNMENT OF THE REPUBLIC OF VIETNAM)); AND ONLY ONE ARMY, THE ARMED FORCES OF THE REPUBLIC OF VIETNAM; AND THAT THE ONLY OBSTACLE TO SIGNING THE PEACE AGREEMENT IS THE OBSTRUCTION OF HANDI IN WANTING TO MAINTAIN ITS TROOPS IN SOUTH VIETNAM AND TO RESERVE THE RIGHT TO INTERVENE IN SOUTH VIETNAMESE AFFAIRS.

IN THE COURSE OF ((HIS)) SPEECH, ISHAM SIMPLY URGED THE COMMUNIST SIDE TO AVOID ACCUSATIONS OF BAD FAITH IN ORDER TO PERMIT THE PURSUIT OF SERIOUS NEGOTIATIONS. HE REAFFIRMED THE U.S. DESIRE TO BRING ABOUT A JUST AND HONORABLE SETTLEMENT.

AFTER SOME BRIEF INTERRUPTIONS FROM ONE SIDE AND THE DTHER. THE TWO SIDES AGREED TO MEET AGAIN ON THURSDAY. 18 JANUARY, ON THE PROPOSAL OF DINH BA THI.
