



NSA/CSS Evaluated Products List for Hard Disk Drive Destruction Devices

OVERVIEW

Devices included on this list have passed evaluation by meeting requirements set by the NSA/CSS for the destruction of magnetic hard disk drives. Meant to serve as guidance, inclusion in this document is not an endorsement by the NSA/CSS or the U.S. Government. All hard disk drive disintegrators sanitize TS/SCI and below. All hard disk drives must be degaussed before deformation.

The NSA/CSS conducts continuous research on data recovery. This document is updated on an as-needed basis. The procedures for administration and distribution of the EPL are subject to change without notice. Please see Expired Products list for more information about removed products.

REQUIREMENTS SUMMARY

For Deformers: The device must deform the platter(s) of a hard disk drive in 30 seconds or less, by bending, punching, or waffling.

For Disintegrators: The device must reduce the hard disk drive to a maximum edge size of 2 millimeter or less.

Inclusion in this list does not guarantee the continued performance of equipment. Customers should re-test equipment according to manufacturer guidance.

Hard disk drives sanitization requirements:

- Regular HDD
 - o Degauss then Deform by any means
 - o Disintegrate to 2 mm with EPL approved device
 - o Incinerate to 670° C
- Hybrid HDD:
 - o Separate HDD portion and external circuit board. Follow sanitization procedures above for the HDD portion and follow Solid State Storage Device EPL for the circuit board
 - o Disintegrate the entire device to 2 mm with EPL approved device
 - o Incinerate to 670° C
- HAMR or MAMR Drives:
 - o Incinerate to 670° C

IMPORTANT REMINDERS

This list serves as guidance for the deformation and disintegration of magnetic hard disk drives.

Remove all labels or markings that indicate previous use or classification.

When used on their own, hard disk drive deformers DO NOT sanitize magnetic storage devices. The hard disk drive deformers must be used in conjunction with an EPL approved magnetic degausser for magnetic hard disk drive sanitization.

Each device offers different convenience features, capacities, feed sizes, footprints and power requirements. Contact the vendor to identify the unit(s) best suited to your site's needs.

Equipment is listed in alphabetical order by vendor. Models that are no longer manufactured but still approved are included as well. Model numbers on equipment must match the model numbers shown in this list.
