

NSA/CSS Expired Products List for **All Products**

OVERVIEW

Devices included on this list were previously approved and met requirements set by the NSA/CSS for sanitizing storage devices, but no longer meet current requirements. Meant to serve as guidance, inclusion in this document is not an endorsement by the NSA/CSS or the U.S. Government. All listed products are authorized to sanitize TS/SCI and below until listed expiration date.

QUALIFICATIONS FOR APPROVAL

Performance testing requirements for specific product categories can be found on the associated EPL documents.

Devices that meet the NSA/CSS sanitization specification for specific media storage types are identified as such within the appropriate EPL documents.

Equipment is listed in alphabetical order by vendor and this EPL contains all previously approved products that are subject to a six year extension for DoD use. Models that are no longer manufactured are included.

Vendors submitting equipment for evaluation will no longer have their return shipping costs funded by NSA.

WHAT YOU NEED TO KNOW

- 1. The NSA/CSS conducts continuous research on data recovery and may remove products from this EPL as the data storage industry changes.
 - When a product is removed from this EPL, a six year grace period is in effect for DoD customers. IC customers should follow your organization's policy regarding this matter. Government Contractors should follow guidance/policy of their cognizant government industrial security oversight organization.
- This list serves as guidance for devices subject to a six year extension as authorized by DoD 5200.01 V3 Enclosure 3 Section 17.
- 3. Inclusion in this list does not guarantee the continued performance of equipment. Customers should re-test equipment according to the manufacturer.
- 4. In all cases, should any previously approved equipment need to be replaced or otherwise require a repair/replacement of a critical assembly (e.g. Shredder blade assembly, capacitor bank, etc.) the unit must be replaced with one listed on the appropriate EPL.
