

MEMORANDUM FOR THE MEMBERS OF USCIB

SUBJECT: Collaboration Between NSA and DSB

1. Reference is made to the Melbourne Tripartite Conference papers which were inclosed with USCIB 10./5, dated 12 November 1954.

2. The general principles of collaboration, as recommended by the Conference, have been approved by the U.S. and the Commonwealth nations concerned. Accordingly, NSA and DSB will collaborate directly on those DSB tasks which the appropriate U.S. authorities have accepted as falling within the field of collaboration. A list of such tasks was included among the conference papers referred to above, and was accepted by USCIB.

3. On 5 November 1954, the Director, NSA, received a letter from the Director, GCHQ, wherein it was stated [redacted]

[redacted] The Director, GCHQ, stated further he is sure it would be to the mutual advantage of NSA and DSB if USCIB would agree to accepting this task as a further one falling within the field of collaboration. He requested, therefore, that the Director, NSA, arrange for USCIB consideration of this proposal by the Director, GCHQ.

4. The Director, NSA, concurs in the GCHQ views indicated above, and recommends that USCIB accept [redacted] as a task falling within the field of NSA-DSB collaboration.
